ALLEMAN CITY COUNCIL MET MONDAY MARCH 13, 2017 AT 7:00PM IN CITY HALL. MAYOR JONES CALLED THE MEETING TO ORDER AT 7:01. THE PLEDGE OF ALLEGIANCE WAS RECITED. MAYOR JONES ASKED FOR ROLL CALL. COUNCIL MEMBERS PRESENT: JOHN HATHAWAY, LOREN STEINKAMP. DAVID WILCOX. BILL STEVENS, PERRY SMITH.

THE PLEDGE OF ALLEGIANCE WAS RECITED.

COUNCIL MINUTES WERE READ. BILL STEVENS MOTIONED THAT THE PREVIOUS MINUTES BE APPROVED. DAVID WILSON SECONDED. PERRY SMITH ABSTAINED. DAVID AYE, JOHN HATHAWAY AYE AND THE PREVIOUS MONTHS MINUTES WERE RESOLVED.

POLK COUNTY SUPERVISOR ROBERT BROWNELL SPOKE ON THE CONDITION OF POLK COUNTY. POLK COUNTY BUDGET WILL BE PUBLISHED ON MARCH 15, 2017 SUPERVISOR BROWNELL RELATED THAT ALTHOUGH EVERYONE IS STRUGGLING NOW, POLK COUNTY HAS HAD A 5 TO 6 PERCENT GROWTH PERIOD. SUPERVISOR BROWNELL APPRECIATED BEING ASKED TO SPEAK AT THE ALLEMAN COUNCIL AND MENTIONED THAT HE WELCOMES CALLS FROM CITIZENS. THE MAYOR AND COUNCIL THANKED SUPERVISOR BROWNELL.

PUBLIC FORUM

TAMMY GOODWIN WITH HER HUSBAND CHRIS SPOKE TO THE COUNCIL ABOUT THE NEW OUT BUILDING ON THEIR NEW RESIDENCE. THEY WANTED TO MAKE SURE THEY WERE NOT BREAKING ANY POLK COUNTY OR ALLEMAN CODES WITH THE BUILDING. THEY PRESENTED THE PLANS TO THE COUNCIL AFTER THEY LOOKED THEM OVER THE COUNCIL SAID ALL WAS APPROVED PROVIDING THE BUILDING IS NOT USED FOR A COMMERCIAL BUSINESS. THE COUNCIL APPROVED THE BUILDING PROVIDING POLK COUNTY APPROVED.
