Mayor Kramme gave a report from Consumers Energy on the new electric being run through Alleman to a new business on the West end of town.

Snow Removal plans are in the works with Public Works. A notation on proper placement of driveway now will be included in the newsletter.

The Construction entrance for the North Polk School High School addition will be 142nd, to 6th Street, to 141st Ave. Bill Stevens made a motion to accept the planned route Arlene Sampson seconded and the motion was approved

Mayor Kramme shared the 2020 building permits issued in Alleman. Mayor Kramme would like Alleman to charge a 20% fee for all building codes. Jim Thornton, Clty Attorney will take to Bret Van Derloon with Polk County.
